



Terms and Conditions — MEDLIFE Rewards Program & SLT Discounts

The MEDLIFE Rewards Program ("Program") rewards participants ("you," "Participant," "User") who complete qualifying actions with discounts toward MEDLIFE Service Learning Trips ("SLT," "SLTs"). By participating, you agree to the Site Terms and Conditions and Site Privacy Policy. High school or under-18 participants must have parental approval and must abide by the High School-Specific Terms & Conditions below.

MEDLIFE reserves the right to modify these Program Terms and Conditions at any time, at its sole discretion and without notice, including the right to change, cancel, suspend, or modify any aspect of the Program — up to and including the removal or invalidation of discount codes already issued. MEDLIFE also reserves the right to disqualify any participant at any time.

Effective August 1, 2026, all previous terms, conditions, promotions, and campaigns related to the prior MEDLIFE Advocate Rewards program — including its points and referral mechanics — are rendered null and void.

SLT Discounts Rules

1. All discounts must be earned and issued to you *before* you complete your trip registration. There are no post-booking discount applications and no manual adjustments after checkout, with the single exception of the Volume Discount described below.
2. Once you qualify, your discount code is emailed to you. There is no app or account dashboard to check — check your email.
3. QR, E-board, and Global Impact discounts combine into a single code. To receive it, submit the Claim Your Discount Code form; MEDLIFE will validate your information against your records before issuing one code covering everything you qualify for. You will not receive separate codes for each discount.
4. Your discount code must be entered at checkout when you register for your SLT — not before, and not after. A code not applied at checkout cannot be refunded or applied retroactively.
5. Discount codes are non-transferable. They may only be used by the participant who earned them and cannot be applied to another participant's registration under any circumstances. Attempting to transfer or apply a discount to another participant's registration may result in forfeiture of the discount and/or disqualification from the Program.
6. Discount codes, once issued, are non-refundable and non-redeemable for cash, and cannot be substituted for any other benefit.



7. Expansion SLT scholarships are not cumulative, and cannot be combined with SLT discounts (see list below).
8. The MVP Discount (full trip cost) is the maximum discount amount that can be applied toward an SLT. Where a participant qualifies for the MVP Discount, no additional discount — including Account/QR, E-board, or Global Impact — may be applied toward trip add-ons, excursions, or any cost beyond the core SLT registration price.

Discounts:

Discount	Amount	Who qualifies	How it's issued
QR	\$50	Any student who submits the QR/account form. Renewable each academic year.	Combined into one code via the Claim Your Discount Code form
E-board	\$50	Active E-board officers who complete onboarding before the school year starts. Hard cutoff at the start of the school year.	Combined into one code via the Claim Your Discount Code form
Global Impact	\$150	Any student who has completed a prior SLT. Issued after each completed trip, not just the first.	Combined into one code via the Claim Your Discount Code form
Volume	Varies by chapter size	All confirmed, fully-paid travelers in a chapter, once the chapter reaches its group-size tier by the final deposit deadline.	Applied by MEDLIFE directly as a refund after the final payment deadline to confirm eligible students. No exceptions for late registrants.
MVP	Full trip cost	E-board officers who recruit 10+ confirmed (deposited) travelers. Stackable per additional 10. Not available to high school students.	Emailed, trip-specific code after chapter nomination and Chapter Coach/MEDLIFE International approval. Code is valid only for the specific trip



			week/location for which it was issued.
Early Bird	\$100	Any student who registers within the seasonal early-bird window.	Applied automatically as a reduced price at checkout.

Stacking: QR, E-board, and Global Impact combine toward the core SLT registration price as a single code (see rule 3 above). Example — a returning, active E-board member could combine QR (\$50) + E-board (\$50) + Global Impact (\$150) for \$250 total off, issued as one code. Where MVP applies, it caps the total discount at full trip cost per student — no further discount stacks beyond that toward add-ons or excursions (see rule 8 above).

Eligibility

Participants must be at least 18 years of age, or — if a high school student or otherwise under 18 — must have parental approval and comply with these High School-Specific Terms. MEDLIFE reserves the right to determine ineligibility at its sole discretion. Users must provide accurate and complete information; false or misleading information may result in disqualification and forfeiture of any discount earned.

High School-Specific Terms: High school students are eligible for all SLT discounts on the same terms as college students, with one exception — high school students do not qualify for the MVP Discount.

Conduct and Fraud

MEDLIFE reserves the right to revoke or adjust any discount in cases of suspected fraud, dishonesty, or abuse of the Program, including providing false information or attempting to game the system. MEDLIFE is the sole determiner in cases of suspected abuse, fraud, or breach of these terms, and may terminate a participant's access to the Program and cancel any associated discounts if it determines, in its sole discretion, that the participant has violated these terms.

IMPORTANT: MEDLIFE reserves the right to terminate any user and cancel all associated discounts if it determines, in its sole discretion, that a user has violated these terms and conditions or engaged in any misconduct. MEDLIFE reserves the right to revoke or adjust discounts in cases of suspected fraud, dishonesty, or abuse of the rewards program. This



includes providing false information, attempting to game the system, or any other activity that MEDLIFE deems unethical.

Liability Binding Effects.

By participating in the Program, you agree to and are bound by the Program Terms and Conditions. If you do not wish to agree to and abide by the Program Terms and Conditions in their entirety, you are not authorized to participate in the Program.

Release.

By participating in the Program, Participants release MEDLIFE, subsidiaries, affiliates, suppliers, advertising, and promotions agencies, and their respective directors, officers, employees, and agents from any and all liability for any loss, harm, damages, cost, or expense, including, without limitation, property damages, personal injury and/or death, out of or in any way connected to the Program and/or the use of any Program rewards.

Indemnification.

Participants agree to indemnify, defend, and hold MEDLIFE and its representatives and agents harmless from and against any and all third-party claims, demands, liabilities, costs, or expenses, including attorney's fees and costs, arising from, or related to any breach by the participant of any of these Program Terms and Conditions or any violation by Participant of applicable law.

Other Terms General Terms.

These Program Terms and Conditions constitute the entire agreement between Participants and MEDLIFE concerning Participants' use of the Program. The failure of MEDLIFE to exercise or enforce any right or provision of these Program Terms and Conditions shall not constitute a waiver of such right or provision.
